

## **Arts & Culture Grant Program:** 2023 Guidelines

Foundation for MetroWest (FFMW) envisions a region where artistic and cultural initiatives are centered as a key component to cultivating vibrant communities and a sense of belonging for all residents. Our mission for the 2023 Arts & Culture Grant Program is to invest in local nonprofit organizations whose primary mission is to provide access to arts and cultural initiatives in the region.

This year, the Foundation for MetroWest seeks to award **one-time general operating grants of up to** \$10,000\* to support arts & culture nonprofits in MetroWest. Grant decisions and amounts will be determined based on a variety of factors, including:

- Organization size understanding the impact of a grant of this size for your organization
- Location(s) of impact demonstrating commitment to MetroWest and role in the region's cultural ecosystem
- Organization impact and reach including population served, type(s) of programming offered, etc.
- Alignment with the Foundation's priorities outlined below •

\*Maximum grant size will be 10% of the organization's annual operating budget or \$10,000, whichever is less.

In 2023, the Foundation will be prioritizing organizations that are demonstrating a commitment to one or more of the following:

- Proactively providing equitable access to arts education, visual arts, or performing arts initiatives for marginalized and under resourced residents
- Celebrating and/or preserving the region's vast history and cultural heritage
- Encouraging and increasing opportunities for culturally diverse voices and communities to create • and participate in arts & cultural activities
- Promoting arts & culture as an engine of social and economic vitality in the region •
- Fostering innovation and community collaboration •

As our MetroWest communities continue to change and evolve, we recognize the importance of arts & culture to help us learn, connect, thrive, and celebrate one another. We look forward to hearing how we can consider supporting nonprofit partners in need of additional funding to sustain their efforts or transform their work to benefit MetroWest.

#### **GRANT PROCESS**

The 2023 grant cycle is an online process and will operate based on the following timeline:

- August 14<sup>th</sup>, 9:00 AM
- September 15<sup>th</sup>, 5:00 PM
- October 16<sup>th</sup> to November 3<sup>rd</sup>
- Deadline for proposals

### **ELIGIBILITY**

Applicants must:

- Have 501(c)(3) tax status as a registered nonprofit organization OR have an eligible fiscal sponsor
- Not discriminate in the hiring of staff or the provision of services on the basis of race, religion, gender or gender identity, sexual orientation, age, national origin, or disability
- Serve one or more of the following MetroWest cities/towns: Acton, Ashland, Boxborough, Carlisle, Concord, Dedham, Dover, Framingham, Harvard, Holliston, Hopkinton, Hudson, Lexington, Lincoln, Marlborough, Maynard, Medfield, Medway, Millis, Natick, Needham, Sherborn, Southborough, Stow, Sudbury, Walpole, Waltham, Wayland, Wellesley, Westborough, Weston, Westwood

Ineligible organizations or requests include:

- City/town agencies, including libraries
- Individuals
- Schools private, public, pre-K, charter, or Chapter 766
- Human service organizations providing arts-based programs to their clients

#### SELECTION CRITERIA

When reviewing proposals, Foundation staff and Distribution Committee members will prioritize organizations who:

- have a strong and existing commitment to serving MetroWest
- demonstrate strong leadership and financial stability or a commitment to achieving financial stability
- have a clear and meaningful impact on the community as a whole or their intended beneficiaries
- clearly articulate how funding from the Foundation will be meaningful for the organization

#### HOW TO APPLY

- 1. Beginning August 14<sup>th</sup> applicants will have access to the application form online.

Awards will be determined the week of December 4<sup>th</sup>. All applicants will be notified by email of decisions.
